

Promotional Period

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a monthly "Super Progressive Cash Jackpot & Free Play Giveaway" promotion on select Thursdays January through June in 2021 from 5:00pm-8:00pm.
- 2. A total of two hundred and forty (240) winners will be randomly selected throughout the promotional period and awarded Free VLT Play or cash.
- 3. On each of the dates ten (10) winners will be selected approximately every hour (60 minutes). A total of forty (40) winners will be selected each promotion day beginning at 5:00pm and concluding at 8:00pm. Drawing dates:
 - Thursday, January 28, 2021
 - Thursday, February 25, 2021
 - Thursday, March 25, 2021
 - Thursday, April 29, 2021
 - Thursday, May 27, 2021
 - Thursday, June 24, 2021
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

- 1. Must be a member of the mychoice program.
- 2. Must be 21 years of age or older to obtain a mychoice card.
- 3. No purchase necessary to receive a mychoice card.
- 4. A valid government issued photo ID is required to verify age and identity.
- 5. All mychoice members who are actively playing on a VLT machine or swipe at a marketing kiosk within thirty (30) minutes of each drawing will be eligible to win.
- 6. Qualifying mychoice members can win a total of two (2) times per drawing date.

Entry Earning

- Sweepstake entries for the Super Progressive Cash Jackpot & Free Play Giveaway will be earned through play throughout each respective qualification period to be eligible for each drawing date and time. Each qualification period will begin at the start of each month of the promotion. Each qualification period is listed below beginning at 5:00am on the first day and ending at 7:59pm on the final day:
 - Friday, January 1, 2021 Thursday, January 28, 2021
 - Saturday, February 1, 2021 Thursday, February 25, 2021
 - Monday, March 1, 2021 Thursday, March 25, 2021

 - Tuesday, June 1, 2021 Thursday, June 24, 2021
- 2. mychoice members receive one (1) entry for every five (5) tier points earned (\$25 coin-in) through play.
- 3. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by swiping at a marketing kiosk or actively playing on a VLT machine within thirty (30) minutes of each drawing to be eligible.
- 4. Earned entries up to approximately five (5) minutes before each drawing time will be included in the upcoming drawing. Earned entries may be delayed posting onto a guest's account.



- 5. In the event of a technical delay or malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any issues during the malfunction/outage period will be reviewed and awarded on a case-by-case basis at management's discretion.
- 6. Electronic entries will accumulate during each month of the promotion and reset to zero (0) at the beginning of each month.

Hollywood High Hand Drawings

- 1. On each indicated drawing day & time, ten (10) winners will be called every hour from 5:00pm to 7:00pm.
- 2. The ten (10) selected mychoice members will need to report to the promotional area in the Food Court with their respective mychoice card and valid government issued photo identification. They will have five (5) minutes to report after being announced over the public address system.
- 3. In the event that a winner or winners do not report to the promotional area within the allotted five (5) minutes, one (1) redraw will be conducted. After the redraw, any prizes unclaimed will be forfeited.
- 4. The ten (10) selected mychoice members who claim their prize will stand on the designated floor marks to maintain social distancing during the promotion. One winner at a time will participate in the Hollywood High Hand game.
- 5. The winner will participate in the Hollywood High Hand game. At the beginning of each drawing period, a Marketing Representative will hand shuffle a deck of fifty-two (52) promotional playing cards and place them face down on a display in the Food Court promotional area.
- 6. The winning mychoice member will point to one (1) of the fifty-two (52) displayed promotional playing cards with the objective of selecting the highest card as compared to the other members within the sixty (60) minutes. Once the card selection is made, a Marketing Representative will flip the card to reveal it. Each winning mychoice member will point to their card in the order they were announced over the public address system. The Ace card will hold the highest value followed by the King, then the Queen, then the Jack. The cards containing a numerical value between ten (10) and two (2) will have a value equal to the number that appears on the card.
- After each winner has come up individually and selected a card, a Marketing Representative will announce the top two (2) winners with the highest card. The top two (2) winning mychoice members will receive a spot into the Final Round immediately following the Wild Card drawing.
- 8. In the event that one or more selected members tie with the same highest card value, the first mychoice member who made the card selection will be considered the higher card.
- 9. The top two (2) highest winning mychoice members will receive a spot in the Final Round at 8:00pm and \$100 Free VLT Play.
- 10. The remaining eight (8) winners will receive a prize of \$250 Free VLT Play.

Wild Card Drawings

- 1. At 8:00pm on each promotional date, a total of four (4) mychoice members will be drawn as Wild Card Finalists. Their prize is a spot into the finale drawing.
- 2. Winners must present their respective mychoice card and valid government issued photo identification. The winners must report to the promotional area in the Food Court within five (5) minutes of being announced over the public address system. After the winners are verified, the "final" drawing will take place.
- 3. In the event that the winners do not report to the promotional area within the allotted five (5) minutes, additional winners will be drawn at a time to report to the promotional table.



The "Final" Drawing

- Each randomly selected mychoice member who was defined as a "finalist" from the 5:00pm, 6:00pm, 7:00pm, and the four (4) Wild Card Drawing winners must check in at the conclusion of the 8:00pm Wild Card Drawing to participate in the "Final" Drawing on each promotional date. Ten (10) guests maximum.
- 2. In the event one of the "finalists" from the 5:00pm, 6:00pm and 7:00pm, drawings are not present at the conclusion of the 8:00pm Wild Card Drawing, that "finalist" will be disqualified and a new finalist will be randomly drawn to take their place in the final drawing. Finalists will be replaced until a total of ten (10) finalists are present.
- 3. The total number of "finalists" inclusive of the Wild Card Drawing winners may not exceed ten (10) MyChoice members.
- 4. Immediately following the Wild Card Drawing, each "finalist" will be called to choose an envelope out of a barrel of five-hundred (500) envelopes in the order of the drawing in which they won in the order they were announced over the public address system. The number of envelopes in the barrel will differ on the guaranteed drawing date, Thursday, June 24, 2021. Each finalist will open their envelope and the next finalist will be called to select their envelope. Only one finalist will be called at a time to select their envelope. On the "guaranteed" drawing date, Thursday, June 24, 2021, finalists will wait to open their envelope until all guests have selected an envelope.
- 5. The drum will be sanitized immediately before and after each finalist by a Hollywood Gaming Marketing Representative. The opening and face of the drum will be sanitized prior to the next finalist coming up to the drum.
- 6. Finalists will be required to use hand sanitizer and latex gloves to participate in this promotion. No exceptions will be made. If a finalist does not follow these procedures, they will forfeit their spot in the finalist drawing. The finalist will not be replaced by another finalist. Only during the final drawing on Thursday, June 24, 2021, replacement winners will be selected. This will be the only date that "finalists" will be replaced.
- 7. Finalists will be required to use hand sanitizer before placing the gloves on and immediately after removing the gloves.
- 8. Hollywood Gaming at Mahoning Valley Race Course will enforce social distancing during each promotion date.
- Each envelope will either contain a Free VLT Play prize equaling \$300, \$500, \$750, or \$1,000 or the Super Progressive Cash Jackpot of \$10,000 cash on Thursday, January 28, 2021 and increasing each month until the guaranteed drawing date.
- 10. If the \$10,000 cash envelope is not selected in January, the Super Progressive Cash Jackpot will increase to \$20,000 for the next drawing on Thursday, February 25, 2021. This process will continue during each monthly drawing until the final drawing on Thursday, June 24, 2021 where the Super Progressive Cash Jackpot will be set at \$60,000 cash.
- 11. If the \$10,000 cash envelope is selected, the Super Progressive Cash Jackpot will reset to \$10,000 during the following month's drawing.
- 12. If the progressive cash prize is chosen before Thursday, June 24, 2021, the new progressive cash prize for June will remain guaranteed to be distributed.

- 14. Randomly selected mychoice members must be present to win any prize.
- 15. Randomly selected mychoice members may be selected up to two (2) times during each promotional date, but only if they were not initially a finale winner of a Hollywood High-Hand drawing. Participants that were not the finale spot winner of their group may be selected as a Wild Card drawing winner at 8:00pm.
- 16. Free VLT Play will be credited to each winner's mychoice account within one (1) hour of being awarded. Winners can simply insert their mychoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
- 17. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
- 18. Free VLT Play credits may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 19. Free VLT Play prizes are not subject to any federal, state, and local taxes.

Guaranteed Cash

- 1. If the cash envelope has not been pulled at any of the drawings from Thursday, January 28, 2021 Thursday, May 27, 2021, the \$60,000 Super Progressive Cash Jackpot will be guaranteed on the drawing date Thursday, June 24, 2021.
- 2. Each of the Hollywood High Hand drawings throughout this drawing date from 5:00pm to 7:00pm will be administered in the same fashion with two mychoice members being made a "finalist".
- 3. The Wild Card Drawing will be administered in the same fashion with four (4) mychoice members being randomly drawn to participate in the "Final" drawing.
- 4. Each randomly selected mychoice member who was defined as a "finalist" from the 5:00pm, 6:00pm and 7:00pm drawings and the four (4) Wild Card Drawing winners will need to report to the Promotions desk at the conclusion of the 8:00pm Wild Card Drawing to participate in the Guaranteed Cash "Final" Drawing.
- 5. In the event one of the "finalists" from the 5:00pm, 6:00pm and 7:00pm drawings are not present at the conclusion of the 8:00pm Wild Card Drawing, that "finalist" will be disqualified, and a new finalist will be randomly drawn to take their place in the Guaranteed Cash "Final" Drawing.
- 6. Immediately following the Wild Card Drawing, each "finalist" will choose an envelope out of a barrel of ten (10) envelopes in the order of the drawing in which they won followed by the four (4) Wild Card Drawing winners in the order they were announced over the public address system. If any of the preliminary drawing "finalists" are disqualified and the position needs redrawn, these winners will select envelopes following the drawn Wild Card Drawing winners in the order they were selected. Each finalist will open the envelope in the order they were called to see what they have won.
- 7. The prizes included in each of the ten (10) envelopes on the final drawing date of the promotion are as follows:
