

# **Virtual Pull Tabs - Official Rules**

#### **Promotional Period**

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a virtual "Mystery Thursday" promotion on Thursdays in April, beginning on April 2, 2025 at 6:00am and concluding on Thursday, April 24, 2025 at 11:59pm.
- 2. Invited guests will receive a mystery PENN Play Bonus that they can claim at a Marketing kiosk. The offer claimed through the Marketing kiosk will be valid on the following dates:
  - o Thursday, April 3, 2025, 6:00am-11:59pm
  - o Thursday, April 10, 2025, 6:00am-11:59pm
  - o Thursday, April 17, 2025, 6:00am-11:59pm
  - o Thursday, April 24, 2025, 6:00am-11:59pm
- 3. Guests will have from 6:00am until 11:59pm on each promotion date to claim and use their offer. Any offer that is not claimed at a Marketing kiosk and or used within the time frame of 6:00am-11:59pm will be forfeited.
- 4. PENN Bonus Play credits will be valid for the specific promotion date only and will expire at 11:59pm at the end of each promotional date (11:59pm on April 3, 11:59pm on April 10, 11:59pm on April 17, and 11:59pm on April 24, 2025).
- 5. All times referred to throughout these rules are Eastern Standard Time (EST).

### **Eligibility**

- 1. Must be a member of the PENN Play program.
- 2. Must be 21 years of age or older to obtain a PENN Play card.
- 3. No purchase necessary to receive a PENN Play card.
- 4. A valid government issued photo ID is required upon request to verify age and identity.
- 5. Eligible PENN Play members will be invited by mail or email and PENN Bonus Play offer will be determined by historical level of play factors including but not limited to trip frequency, VLT machine denominations played, average bet, length of play, and length of time since last visit.
- 6. Each invited guest will have one valid virtual mystery PENN Bonus Play bonus offer per promotion date.
- 7. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.

- 8. Hollywood Gaming at Mahoning Valley Race Course reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or a complimentary reward has been changed, altered or tampered with in any way.
- 9. Use of the PENN Play card indicates acceptance of these Official Rules.
- 10. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them to be the fairest outcome for all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Mahoning Valley Race Course reserves the right to change, modify or cancel this program at any time.
