

\$40k Rising Heat Hot Seat - Official Rules

Promotional Period

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a weekly "\$40k Rising Heat Hot Seat" promotion on select Thursdays in August from 2:00 pm through 8:00 pm.
- 2. A total of fifty-two (52) winners will be randomly selected throughout the promotional period and awarded Free VLT Play.
- 3. On each of the dates one (1) winner will be selected approximately every half hour (30 minutes). A total of thirteen (13) winners will be selected each promotion day beginning at 2:00 pm and concluding at 8:00 pm. Drawing dates:

 - Thursday, August 8, 2019
 - Thursday, August 15, 2019
 - Thursday, August 22, 2019
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

- 1. Must be a member of the MyChoice program.
- 2. Must be 21 years of age or older to obtain a MyChoice card.
- 3. No purchase necessary to receive a MyChoice card.
- 4. A valid government issued photo ID may be required to verify age and identity.
- 5. All MyChoice members who have their MyChoice card properly inserted into a VLT machine at the time of each drawing are eligible to win.
- 6. No entries are required to win.
- 7. Qualifying MyChoice members can win a total of two (2) times per drawing date.

- 1. One (1) winner will be drawn at each drawing time to win free VLT play.
- 2. During each scheduled drawing, the winning MyChoice account number along with the winner's first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
- 3. Winners must be present and have five (5) minutes to claim their prize at the promotions table located at the Food Court.
- 4. In the event a winner is not present after five (5) minutes, the prize will be forfeited from the prize pool. Another name will not be redrawn.
- 5. Free VLT Play will be credited to each winner's MyChoice account within one (1) hour of being awarded. Winners can simply insert their MyChoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
- 6. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
- 7. Free VLT Play credits may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within seventy-two (72) hours.
- 8. Free VLT Play prizes are not subject to any federal, state, and local taxes.

General Rules

- 1. Participants agree to the use of his or her first name, city & state and photograph for advertising and promotional purposes without charge or additional compensation.
- 2. Persons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
