

### Promotional Period

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a monthly "Super Progressive Cash Jackpot & Free Play Giveaway" promotion on select Thursdays throughout the remaining months in 2019 from 5:00pm-8:00pm.
- 2. A total of two hundred forty (240) winners will be randomly selected throughout the promotional period and awarded Free VLT Play or cash.
- 3. On each of the dates five (5) winners will be selected approximately every half hour (30 minutes). A total of forty (40) winners will be selected each promotion day beginning at 5:00 pm and concluding at 8:00 pm. Drawing dates:
  - Thursday, July 25, 2019
  - Thursday, August 29, 2019
  - Thursday, September 26, 2019
  - Thursday, October 31, 2019
  - Thursday, November 21, 2019
  - Thursday, December 26, 2019
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

### **Eligibility**

- 1. Must be a member of the MyChoice program.
- 2. Must be 21 years of age or older to obtain a MyChoice card.
- 3. No purchase necessary to receive a MyChoice card.
- 4. A valid government issued photo ID may be required to verify age and identity.
- 5. All MyChoice members who have their MyChoice card properly inserted into a VLT machine within thirty (30) minutes of each drawing to activate their earned entries are eligible to win.
- 6. Qualifying MyChoice members can win a total of two (2) times per drawing date.

### Entry Earning

- 1. Sweepstake entries for the Super Progressive Cash Jackpot & Free Play Giveaway will be earned through play throughout each respective qualification period to be eligible for each drawing date and time. Each qualification period will begin at the start of each month of the promotion. Each qualification period is listed below beginning at 5:00am on the first day and ending at 8:29pm on the final day:
  - Monday, July 1, 2019 Thursday, July 25, 2019
  - Thursday, August 1, 2019 Thursday, August 29, 2019
  - Sunday, September 1, 2019 Thursday, September 26, 2019

- 2. MyChoice members receive one (1) entry for every five (5) tier points earned (\$25 coin-in) through play.
- 3. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by properly inserting their MyChoice card into any VLT machine.
- 4. Electronic entries will accumulate during each month of the promotion and reset to zero (0) at the beginning of each month.

### Hollywood High Hand Drawings

- 1. On each indicated drawing day & time, five (5) winners will be selected each half hour from 5:00pm 7:30pm.
- 2. The five (5) selected MyChoice members, with their respective MyChoice card and acceptable form of valid identification, must report to the promotional area in the Food Court within five (5) minutes of being announced over the public address system.
- 3. In the event that all five (5) MyChoice members do not report to the promotional area within the allotted five (5) minutes, additional winners will be drawn until all five (5) winners are present.
- 4. Once there are five (5) present selected winners, the five (5) MyChoice members will participate in the Hollywood High Hand game. At the beginning of each drawing period, a Marketing Representative will hand shuffle a deck of fifty-two (52) promotional playing cards and place them face down on a display in the Food Court promotional area.
- 5. Each winning MyChoice member will select one (1) of the fifty-two (52) displayed promotional playing cards with the objective of selecting the highest card as compared to the other selected members. Each winning MyChoice member will select their card in the order they were announced over the public address system. The Ace card will hold the highest value followed by the King, then the Queen, then the Jack. The cards containing a numerical value between ten (10) and two (2) will have a value equal to the number that appears on the card.
- 6. Winning MyChoice members will select cards in the order they were announced.
- 7. In the event that one or more selected MyChoice members tie with the same highest card value, the tied MyChoice members will select another promotional playing card until a definitive winner is selected.
- 8. The winning MyChoice member will receive a spot in the Final Round at 8:00pm and \$100 Free VLT Play.
- 9. The remaining four (4) winners will receive a prize of \$250 Free VLT Play.

### Wild Card Drawings

1. At 8:00pm on each promotional date, four (4) MyChoice members will be drawn as Wild Card Finalists.



- 2. The four (4) selected MyChoice members, with their respective MyChoice card and acceptable form of valid identification, must report to the promotional area in the Food Court within five (5) minutes of being announced over the public address system.
- 3. In the event that all four (4) MyChoice members do not report to the promotional area within the allotted five (5) minutes, additional winners will be drawn until all four (4) winners are present.

#### The "Final" Drawing

- 1. Each randomly selected MyChoice member who was defined as a "finalist" from the 5:00pm, 5:30pm, 6:00pm, 6:30pm, 7:00pm, and 7:30pm drawings and the four (4) Wild Card Drawing winners must be present at the conclusion of the 8:00pm Wild Card Drawing to participate in the "Final" Drawing on each promotional date.
- 2. In the event one of the "finalists" from the 5:00pm, 5:30pm, 6:00pm, 6:30pm, 7:00pm, and 7:30pm drawings are not present at the conclusion of the 8:00pm Wild Card Drawing, that "finalist" will be disqualified and will not be replaced by another "finalist".
- 3. "Finalists" may not vacate the Food Court promotional area without the approval of the Marketing Representative that is administering the drawing. Those who do not follow this rule will be disqualified from the "Final" drawing.
- 4. The total number of "finalists" inclusive of the Wild Card Drawing winners may not exceed ten (10) MyChoice members.
- 5. At approximately 8:15pm, all ten (10) "finalists" will choose an envelope out of a barrel of five-hundred (500) envelopes in the order of the drawing in which they won followed by the four (4) Wild Card Drawing winners in the order they were announced over the public address system. The number of envelopes in the barrel will differ on the final drawing date, Thursday, December 26 if the cash prize is not pulled during the other months' drawings. After all ten (10) "finalists" have chosen an envelope, a Marketing Representative will instruct the MyChoice members to open their envelope at the same time.
- 6. Each envelope will either contain a Free VLT Play prize equaling \$300, \$500, \$750, or \$1,000 or the Super Progressive Cash Jackpot of \$10,000 cash.
- 7. If the \$10,000 cash envelope is not selected, the Super Progressive Cash Jackpot will increase to \$20,000 for the next drawing on Thursday, August 29, 2019. This process will continue during each monthly drawing until the final drawing of the year on Thursday, December 26, 2019 where the Super Progressive Cash Jackpot will be set at \$60,000 cash.
- 8. If the \$10,000 cash envelope is selected, the Super Progressive Cash Jackpot will reset to \$10,000 during the following month's drawing.

- 10. Randomly selected MyChoice members must be present to win any prize.
- 11. Randomly selected MyChoice members may not be selected for any drawing time or prize more than one time throughout the event on that day.
- 12. Free VLT Play will be credited to each winner's MyChoice account within one (1) hour of being awarded. Winners can simply insert their MyChoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
- 13. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
- 14. Free VLT Play credits may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within seventy-two (72) hours.
- 15. Free VLT Play prizes are not subject to any federal, state, and local taxes.

### <u>Guaranteed Cash</u>

- 1. If the cash envelope has not been pulled at any of the drawings from Thursday, July 25, 2019 Thursday, November 21, 2019, the \$60,000 Super Progressive Cash Jackpot will be guaranteed on the final drawing date Thursday, December 26, 2019.
- 2. Each of the Hollywood High Hand drawings throughout this drawing date from 5:00pm to 7:30pm will be administered in the same fashion with one MyChoice member being made a "finalist".
- 3. The Wild Card Drawing will be administered in the same fashion with four (4) MyChoice members being randomly drawn to participate in the "Final" drawing.
- 4. Each randomly selected MyChoice member who was defined as a "finalist" from the 5:00pm, 5:30pm, 6:00pm, 6:30pm, 7:00pm, and 7:30pm drawings and the four (4) Wild Card Drawing winners must be present at the conclusion of the 8:00pm Wild Card Drawing to participate in the Guaranteed Cash "Final" Drawing.
- 5. In the event one of the "finalists" from the 5:00pm, 5:30pm, 6:00pm, 6:30pm, 7:00pm, and 7:30pm drawings are not present at the conclusion of the 8:00pm Wild Card Drawing, that "finalist" will be disqualified, and a new finalist will be randomly drawn to take their place in the Guaranteed Cash "Final" Drawing.



- 6. At approximately 8:15pm, all ten (10) "finalists" will choose an envelope out of a barrel of ten (10) envelopes in the order of the drawing in which they won followed by the four (4) Wild Card Drawing winners in the order they were announced over the public address system.
