

# October Monster Match - Official Rules

#### Promotional Period

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a weekly "October Monster Match" promotion on Saturdays in October from 4:00 pm through 8:00 pm.
- 2. A total of sixty (60) winners will be randomly selected throughout the promotional period and awarded Free VLT Play or cash.
- 3. On each of the dates three (3) winners will be selected approximately every hour. A total of fifteen (15) winners will be selected each promotion day beginning at 4:00 pm and concluding at 8:00 pm. Drawing dates:
  - Saturday, October 5, 2019
  - Saturday, October 12, 2019
  - Saturday, October 19, 2019
  - Saturday, October 26, 2019
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

#### <u>Eligibility</u>

- 1. Must be a member of the MyChoice program.
- 2. Must be 21 years of age or older to obtain a MyChoice card.
- 3. No purchase necessary to receive a MyChoice card.
- 4. A valid government issued photo ID may be required to verify age and identity.
- 5. All MyChoice members who activate their entries within thirty (30) minutes of each drawing will be eligible to win.
- 6. Qualifying MyChoice members can win a total of one (1) time per drawing date.

## <u>Entry Earning</u>

- 1. For every two (2) tier points earned (\$10 coin-in) through play, MyChoice members will earn one (1) entry.
- 2. Entry earning will begin at 12:00am on October 1, 2019 and will end at 8:00pm on October 26, 2019.
- 3. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by properly inserting their MyChoice card into any VLT machine.
- 4. Qualifying MyChoice members can win a maximum of one (1) time during each day of the promotional period.
- 5. Entries will accumulate during the entire promotional period.

## Monster Match Game

- 1. On each indicated drawing day & time, three (3) winners will be selected each hour beginning at 4:00 pm and ending at 8:00 pm.
- 2. All drawings will be held in the Food Court promotional area.

- 3. There will be twenty-four (24) Monsters on the game board with one (1) behind each game piece on the Promotional Screen. Guests will have the opportunity to match as many pairs of identical monsters as they can in a one (1) minute time frame. Guests will receive Free VLT Play for each successful match during the game.
- 4. The possible prizes during the October Monster Match game are as follows:

- 1. Three (3) winners will be drawn at each drawing time to play the game.
- 2. During each scheduled drawing, the winning MyChoice account number along with the winner's first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
- 3. Winners must be present and have five (5) minutes to claim their prize at the promotions table located at the Food Court.
- 4. In the event a winner is not present after five (5) minutes, replacement winners will be selected up to two (2) additional times.
- 5. If no winner is present after the second redraw, the prize will be forfeited from the prize pool.
- 6. Free VLT Play will be credited to each winner's MyChoice account within one (1) hour of being awarded. Winners can simply insert their MyChoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
- 7. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
- 8. Free VLT Play credits may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within seventy-two (72) hours.

9. Free VLT Play prizes are not subject to any federal, state, and local taxes.
